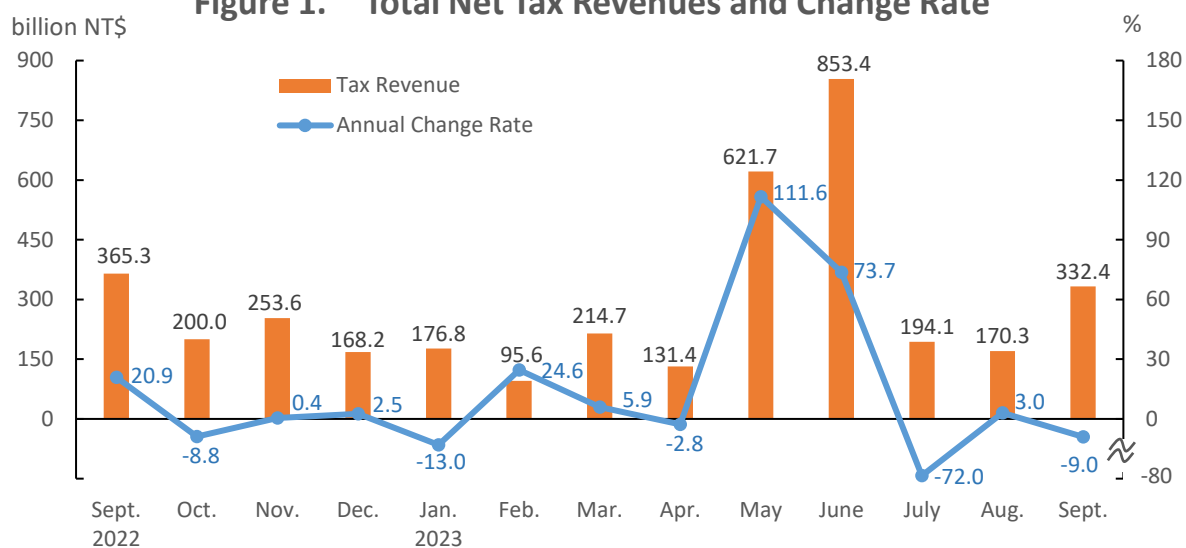
Preliminary Total Net Tax Revenue for September 2023



Highlights

For the month of September 2023, total net tax revenue was NT\$ 332.4 billion, which is NT\$ 32.8 billion (-9.0%) less than the same month last year, while cumulative January to date was NT\$ 2,790.5 billion, NT\$ 164.5 billion (+6.3%) more than the same period last year. Total net tax revenue (Year to date, YTD) as of cumulative distributed budget was 112.3%.

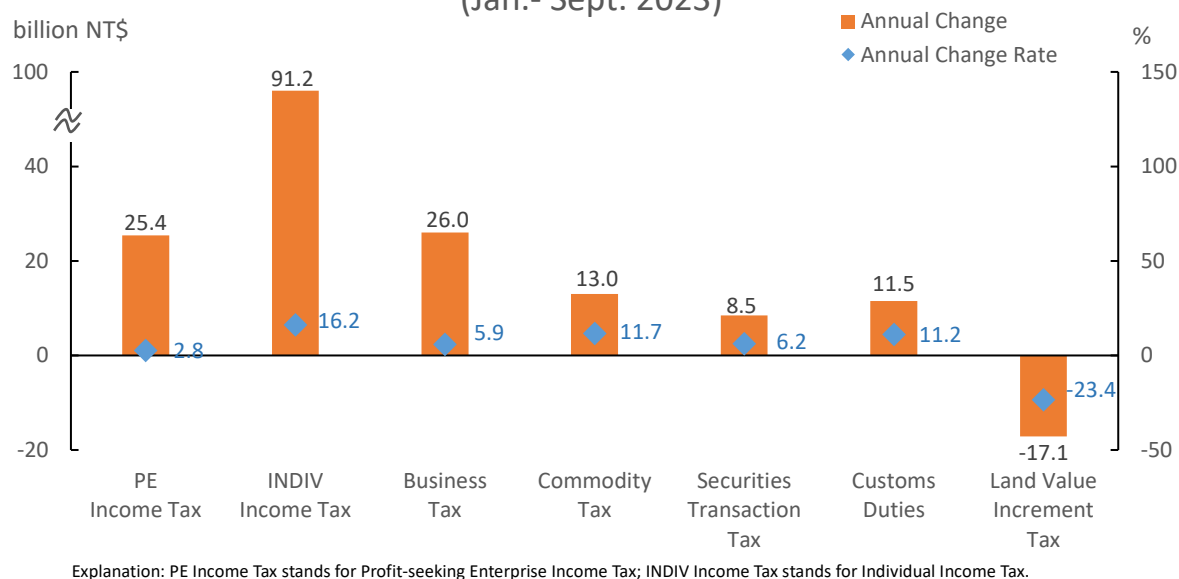
Figure 1. Total Net Tax Revenues and Change Rate



Changes in Major Types of Taxes

In YTD total net tax revenue (September 2023) compared with the same period of last year, Individual Income Tax Increased NT\$ 91.2 billion, Business Tax Increased NT\$ 26.0 billion and Profit-seeking Enterprise Income Tax Increased NT\$ 25.4 billion, while Land Value Increment Tax decreased NT\$ 17.1 billion.

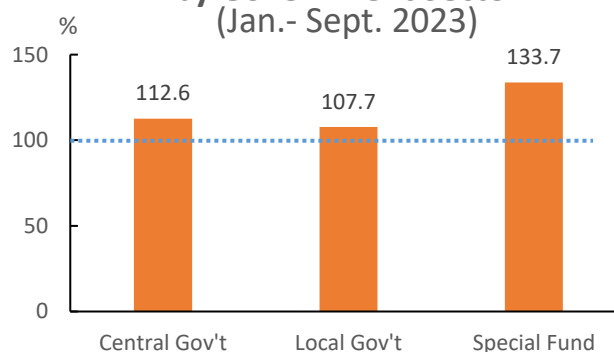
Figure 2. Total Net Tax Revenue and Change Rate by Major Type of Tax (Jan.- Sept. 2023)



By Sectors of Government

For Central Government, total net tax revenue(YTD) was NT\$ 2,064.0 billion, which is NT\$ 147.4 billion(+7.7%) more than the same period last year; the budget achieving rate was 112.6%. For Local Government, total net tax revenue(YTD) was NT\$ 604.2 billion, which is NT\$ 9.2 billion (+1.5%) more than the same period last year; the budget achieving rate was 107.7%.
