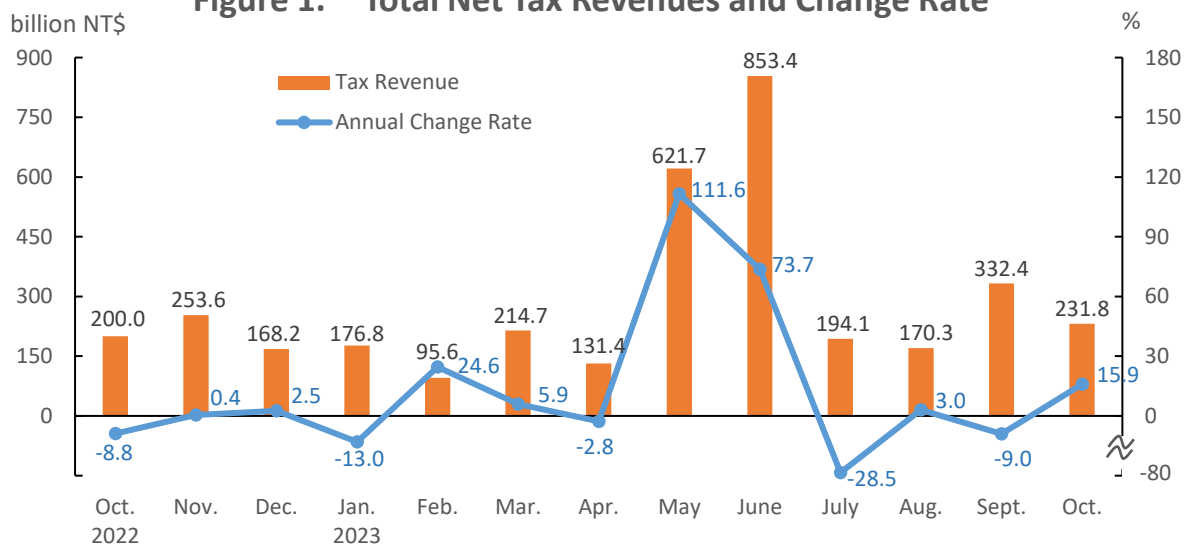
## Preliminary Total Net Tax Revenue for October 2023



### Highlights

For the month of October 2023, total net tax revenue was NT\$ 231.8 billion, which is NT\$ 31.8 billion (+15.9%) more than the same month last year, while cumulative January to date was NT\$ 3,022.3 billion, NT\$ 196.3 billion (+6.9%) more than the same period last year. Total net tax revenue (Year to date, YTD) as of cumulative distributed budget was 112.0%.

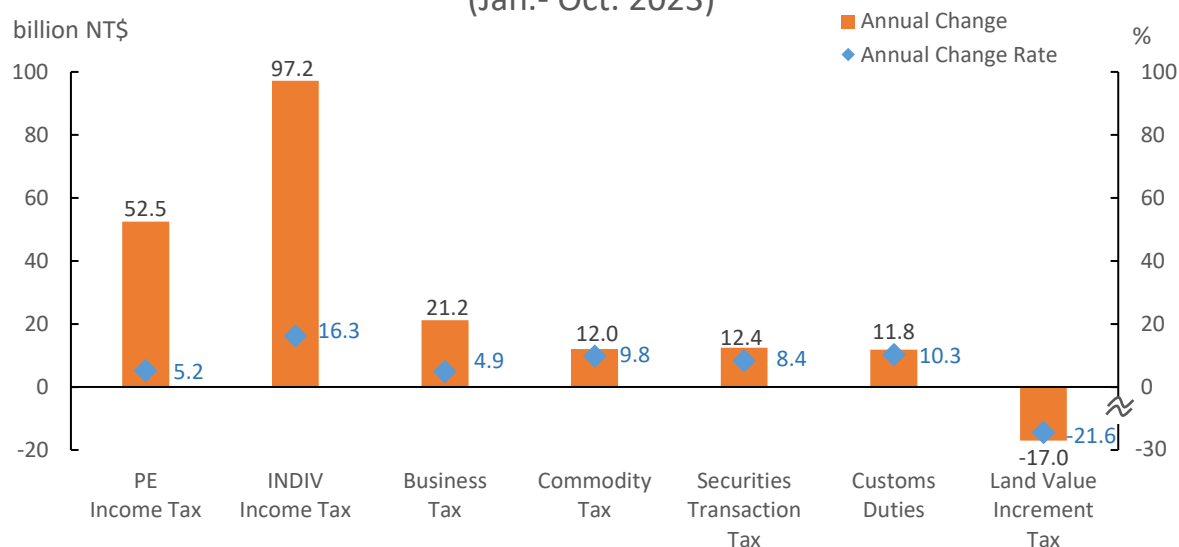
**Figure 1. Total Net Tax Revenues and Change Rate**



### Changes in Major Types of Taxes

In YTD total net tax revenue (October 2023) compared with the same period of last year, Individual Income Tax Increased NT\$ 97.2 billion, Profit-seeking Enterprise Income Tax Increased NT\$ 52.5 billion and Business Tax Increased NT\$ 21.2 billion, while Land Value Increment Tax decreased NT\$ 17.0 billion.

**Figure 2. Total Net Tax Revenue and Change Rate by Major Type of Tax (Jan.- Oct. 2023)**

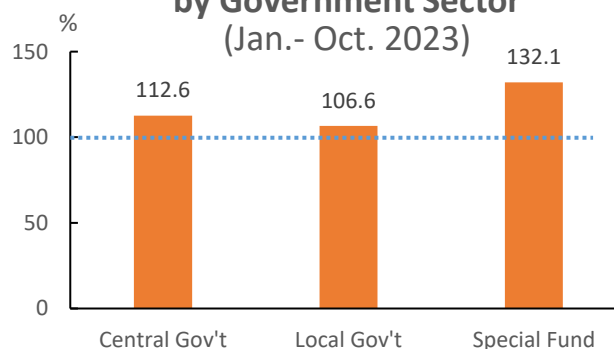


Explanation: PE Income Tax stands for Profit-seeking Enterprise Income Tax; INDIV Income Tax stands for Individual Income Tax.

### By Sectors of Government

For Central Government, total net tax revenue(YTD) was NT\$ 2,257.2 billion, which is NT\$ 176.1 billion(+8.5%) more than the same period last year; the budget achieving rate was 112.6%. For Local Government, total net tax revenue(YTD) was NT\$ 633.2 billion, which is NT\$ 12.0 billion (+1.9%) more than the same period last year; the budget achieving rate was 106.6 %.
