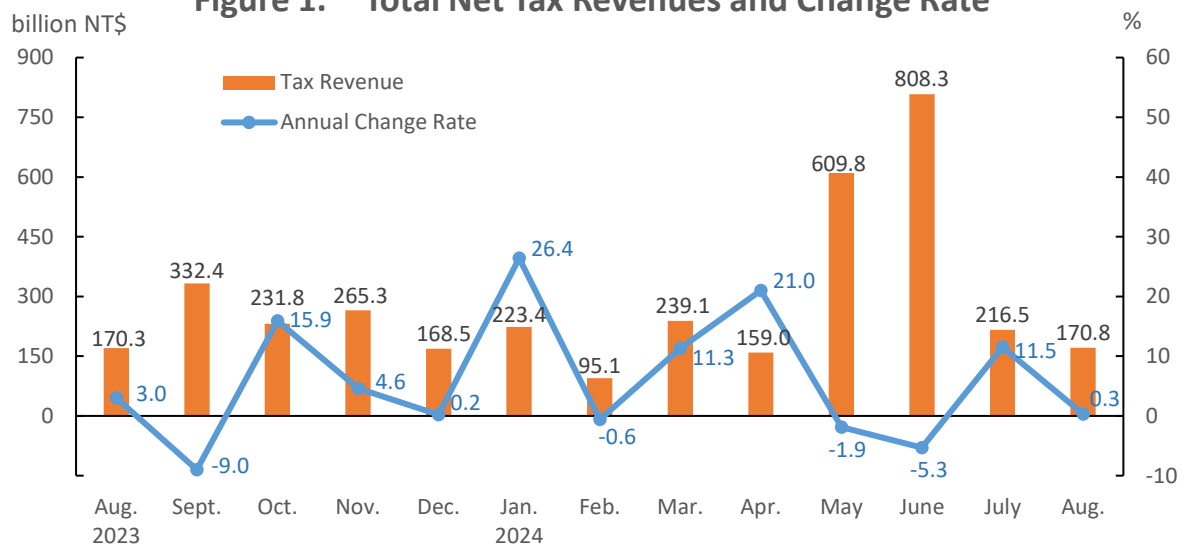
## Preliminary Total Net Tax Revenue for August 2024



### Highlights

For the month of August 2024, total net tax revenue was NT\$ 170.8 billion, which is NT\$ 0.5 billion (+0.3%) more than the same month last year, while cumulative January to date was NT\$ 2,521.9 billion, NT\$ 63.8 billion (+2.6%) more than the same period last year. Total net tax revenue (Year to date, YTD) as of cumulative distributed budget was 109.5%.

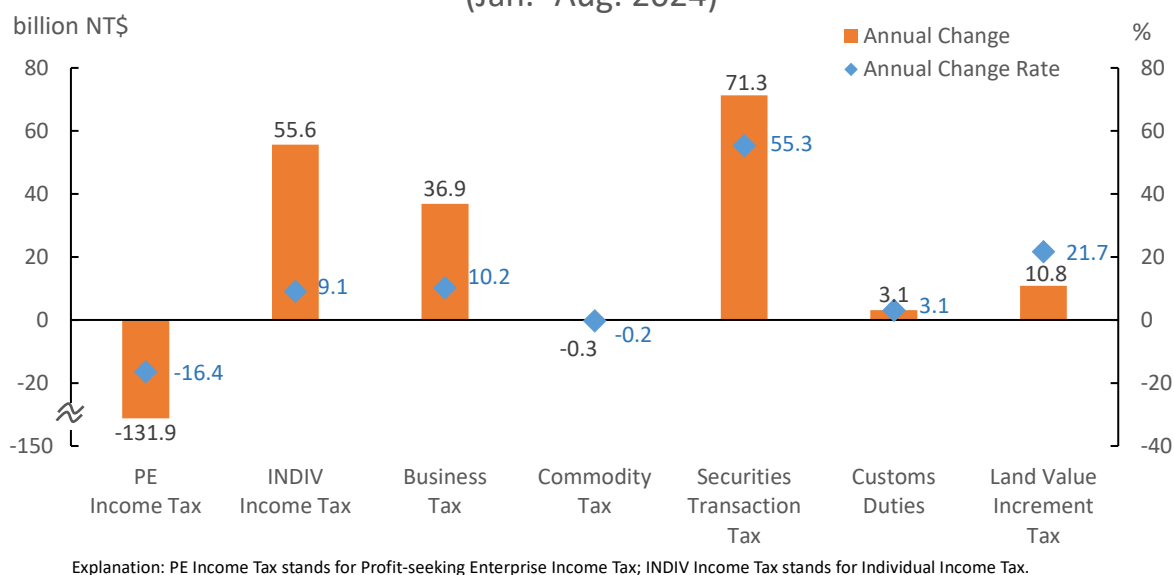
**Figure 1. Total Net Tax Revenues and Change Rate**



### Changes in Major Types of Taxes

In YTD total net tax revenue (August 2024) compared with the same period of last year, Securities Transaction Tax increased NT\$ 71.3 billion, Individual Income Tax increased NT\$ 55.6 billion, and Business Tax increased NT\$ 36.9 billion, while Profit-seeking Enterprise Income Tax decreased NT\$ 131.9 billion.

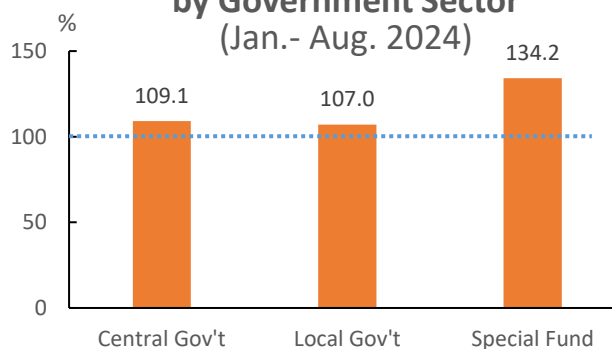
**Figure 2. Total Net Tax Revenue and Change Rate by Major Type of Tax (Jan.- Aug. 2024)**



### By Sectors of Government

For Central Government, total net tax revenue(YTD) was NT\$ 1,846.6 billion, which is NT\$ 12.0 billion(+0.7%) more than the same period last year; the budget achieving rate was 109.1%. For Local Government, total net tax revenue(YTD) was NT\$ 561.1 billion, which is NT\$ 26.4 billion (+4.9%) more than the same period last year; the budget achieving rate was 107.0 %.
