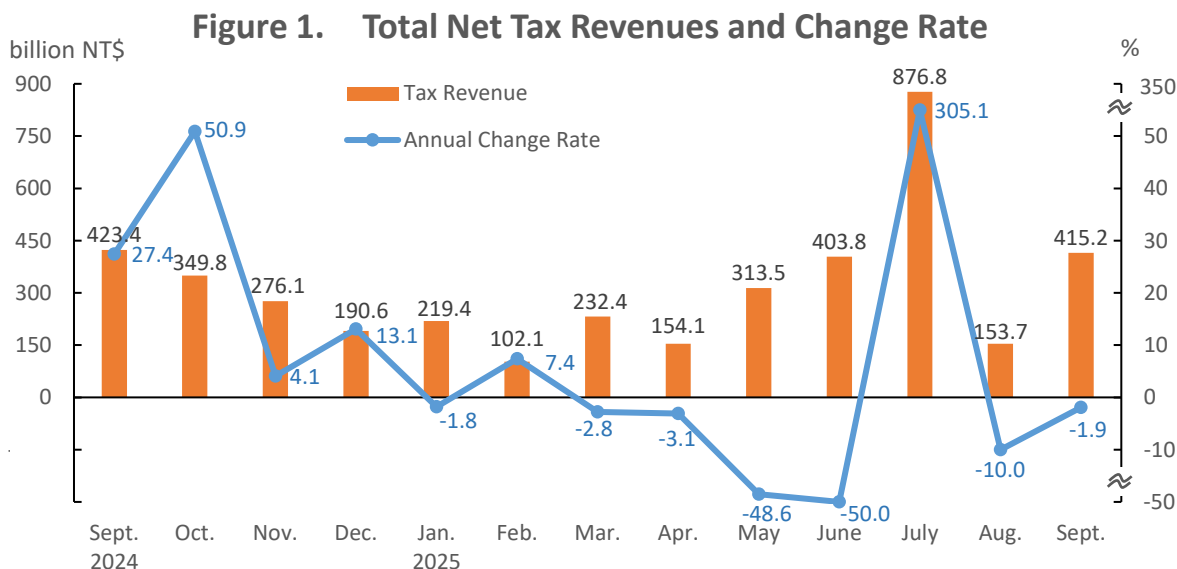

Preliminary Total Net Tax Revenue for September 2025



Highlights

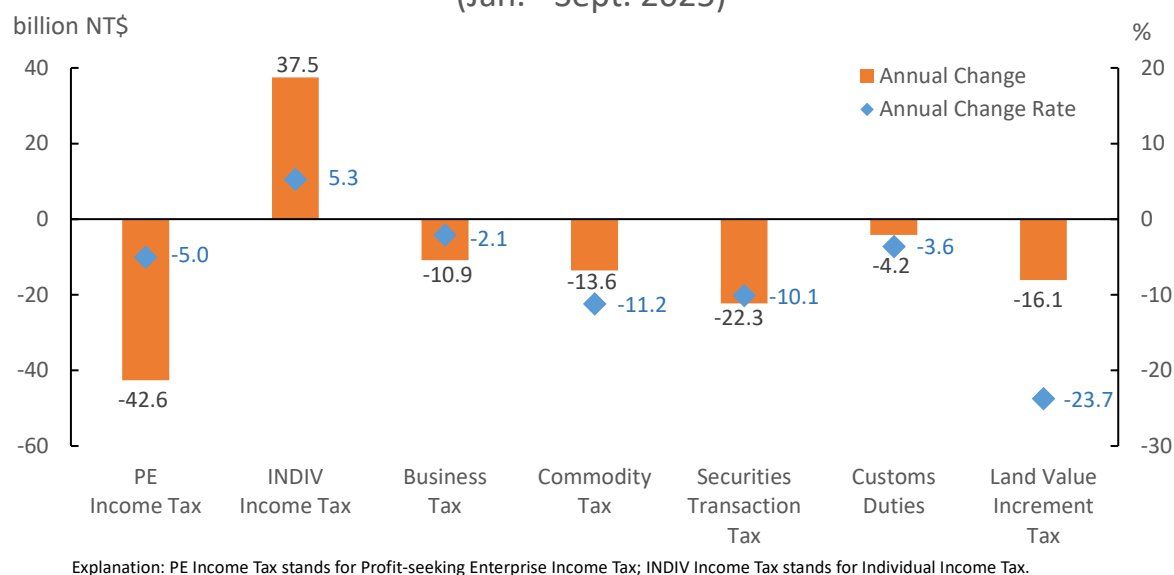
For the month of September 2025, total net tax revenue was NT\$415.2 billion, which is NT\$8.2 billion (-1.9%) less than the same month last year, while cumulative January to date was NT\$2,871.0 billion, NT\$74.3 billion (-2.5%) less than the same period last year. Total net tax revenue (Year to date, YTD) as of cumulative distributed budget was 93.5%.



Changes in Major Types of Taxes

In YTD total net tax revenue (September 2025) compared with the same period of last year, Profit-seeking Enterprise Income Tax decreased NT\$42.6 billion, Securities Transaction Tax decreased NT\$22.3 billion and Land Value Increment Tax decreased NT\$16.1 billion, while Individual Income Tax increased NT\$37.5 billion.

(Jan. - Sept. 2025)**

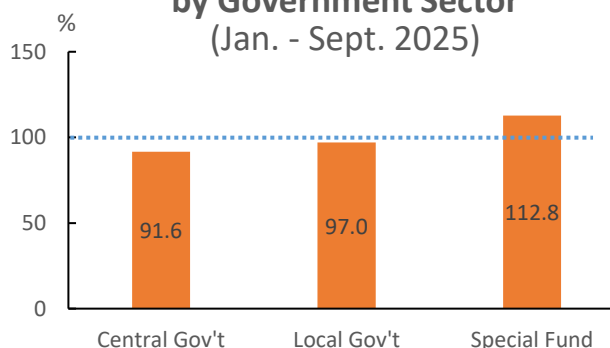


By Sectors of Government

For Central Government, total net tax revenue(YTD) was NT\$2,105.0 billion, which is NT\$36.5 billion(-1.7%) less than the same period last year; the budget achieving rate was 91.6%. For Local Government, total net tax revenue(YTD) was NT\$637.1 billion, which is

NT\$6.2 billion (-1.0%) less than the same period last year; the budget achieving rate was 97.0 %.
