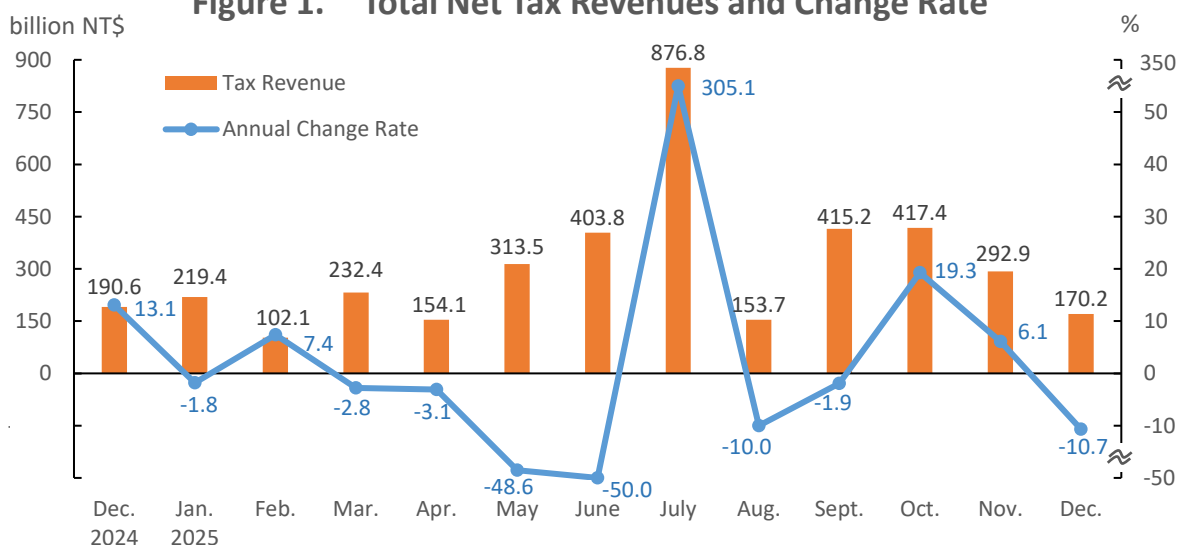
Preliminary Total Net Tax Revenue for December 2025



Highlights

For the month of December 2025, total net tax revenue was NT\$170.2 billion, which is NT\$20.4 billion (-10.7%) less than the same month last year, while cumulative January to date was NT\$3,751.5 billion, NT\$10.4 billion (-0.3%) less than the same period last year. Total net tax revenue (Year to date, YTD) as of yearly budget was 98.7%.

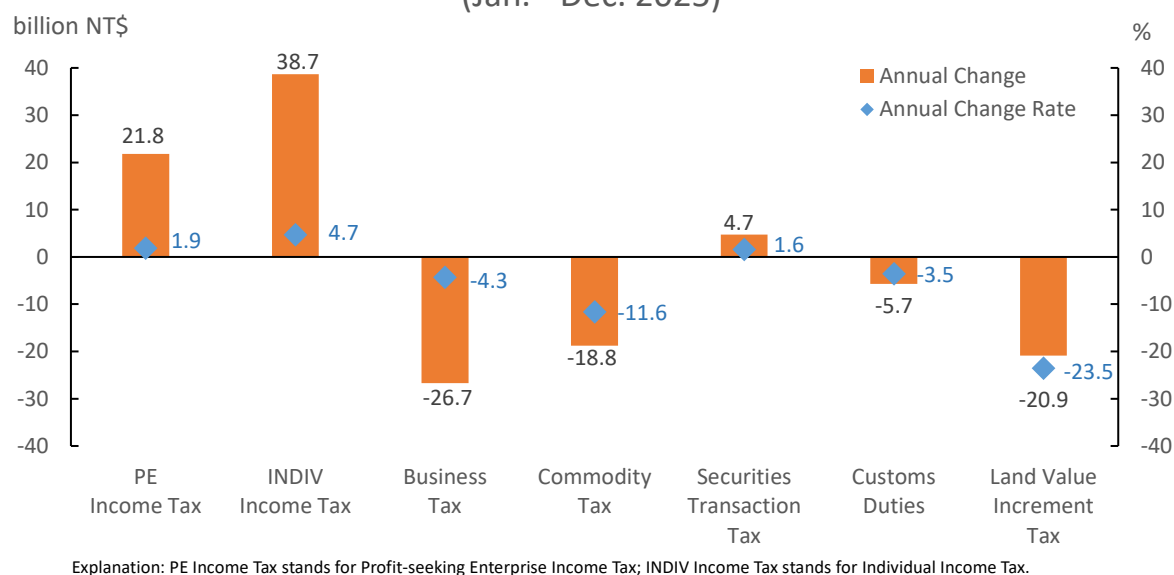
Figure 1. Total Net Tax Revenues and Change Rate



Changes in Major Types of Taxes

In YTD total net tax revenue (December 2025) compared with the same period of last year, Business Tax decreased NT\$26.7 billion, Land Value Increment Tax decreased NT\$20.9 billion and Commodity Tax decreased NT\$18.8 billion, while Individual Income Tax increased NT\$38.7 billion and Profit-seeking Enterprise Income Tax increased NT\$21.8 billion.

(Jan. - Dec. 2025)**

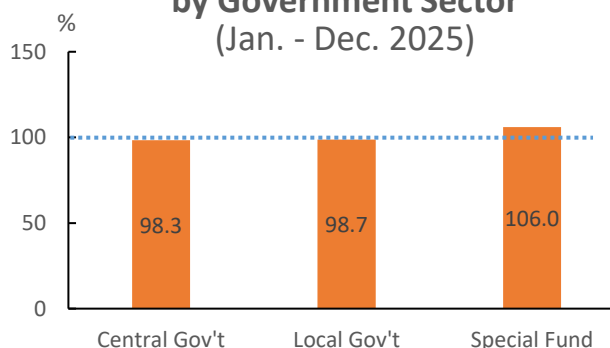


By Sectors of Government

For Central Government, total net tax revenue(YTD) was NT\$2,736.2 billion, which is NT\$46.5 billion(+1.7%) more than the same period last year; the budget achieving rate was 98.3%. For Local Government, total net tax revenue(YTD) was NT\$855.4 billion, which is

NT\$8.4 billion (-1.0%) less than the same period last year; the budget achieving rate was 98.7 %.
