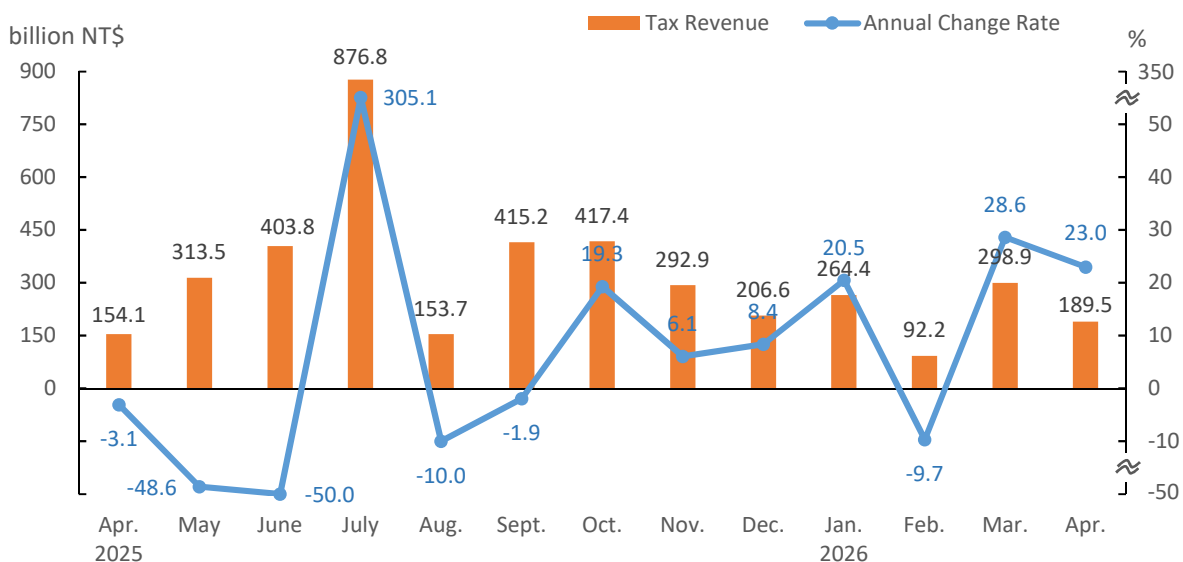
Preliminary Total Net Tax Revenue for April 2026



Highlights

For the month of April 2026, total net tax revenue was NT\$ 189.5 billion, which is NT\$ 35.5 billion (+23.0%) more than the same month last year, while cumulative January to date was NT\$ 845.0 billion, which is NT\$ 137.0 billion (+19.3%) more than the same period last year. Total net tax revenue (Year to date, YTD) as of cumulative distributed budget was 113.7%.

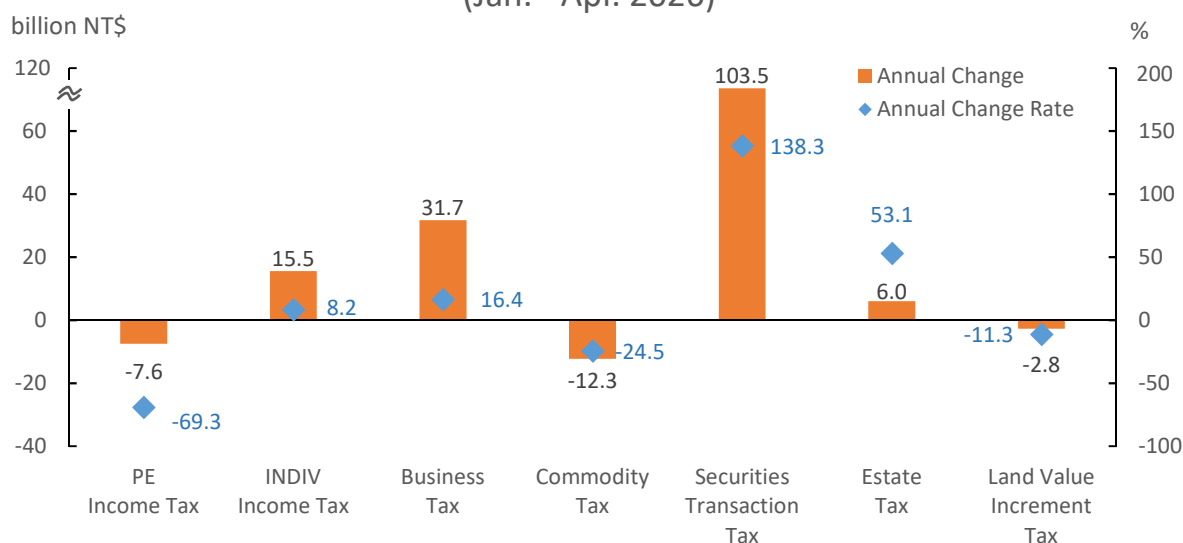
Figure 1. Total Net Tax Revenues and Change Rate



Changes in Major Types of Taxes

In YTD total net tax revenue (April 2026) compared with the same period of last year, Security Transaction Tax increased NT\$103.5 billion, Business Tax increased NT\$31.7 billion, and INDIV Income Tax increased NT\$15.5 billion, while Commodity Tax decreased NT\$12.3 billion.

Figure 2. Total Net Tax Revenue and Change Rate by Major Type of Tax (Jan. - Apr. 2026)

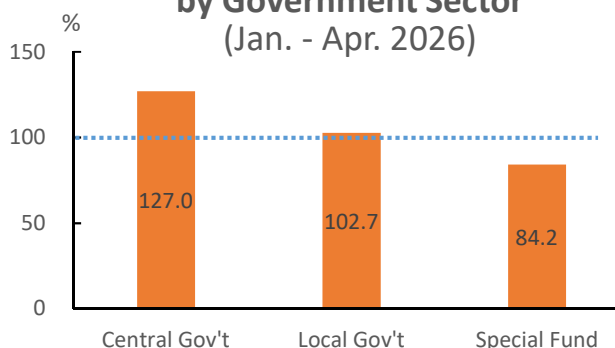


Explanation: PE Income Tax stands for Profit-seeking Enterprise Income Tax; INDIV Income Tax stands for Individual Income Tax.

By Sectors of Government

For Central Government, total net tax revenue(YTD) was NT\$471.5 billion, which is NT\$1.7 billion(-0.4%) less than the same period last year; the budget achieving rate was 127.0%. For Local Government, total net tax revenue(YTD) was NT\$336.5 billion, which is NT\$144.1 billion (+74.9%) more than the same period last year; the budget achieving rate was 102.7 %.
